The Principal is requested to forward **online** all the Examination forms duly certified on or before **22.03.2017** without fail. Forms received after **22.03.2017** will be levied penal fees of **Rs.1000/-** per day.

The Principal is requested to verify the eligibility of the candidates for admission to the above course and forward the examination application form duly certified.

Further, the Principals are requested to enclose the list of admitted candidates for the year 2016-2017 signed by the Director, P.G. Admissions along with the candidates submit 2 (two) soft copies and 2 (two) hard copies. Approved copy from Academic Audit Cell, O.U. and clearance certificate from Nodal Officer, Statistical Cell, O.U.
