The Principal is requested to forward all the Examination forms duly certified on or before 25.04.2017 without fail. Forms received after 25.04.2017 will be levied penal fees of Rs.1000/- per day.

The Principal is requested to verify the eligibility of the candidates for admission to the above course and forward the examination application form duly certified.

Admissions along with the candidates submit 2 (two) soft copies and 2 (two) hard copies.
